TERMS, CONDITIONS, AND RESTRICTIONS THAT APPLY TO THE ISSUANCE OF THIS PERMIT AND THE WORK TO BE DONE

This permit is signed by the Sugarcreek Township Trustees under authority of resolutions heretofore adopted by the Board of Sugarcreek Township Trustees and no work shall be undertaken by the applicant except as the Board has authority to issue a permit for as found in House Bill No. 576, Amended and effective August 16, 1955 which is to enact sections 5571.16 and 5571.99 of the Revised Code of Ohio.

The Board of Sugarcreek Township Trustees hereby requires any person, company or corporation to obtain a permit before making any excavation in a public road within their jurisdiction. The board as a condition to the granting of this permit requires the applicant signing this application agree to the following:

1. The applicant will submit a complete print indicating the location, size, type, and duration of the excavating.
2. The applicant as well as his/her contractor shall together be responsible for restoring the road and the right of way to as good a condition as originally found and repair and replace any and all roadway structures without cost to the Sugarcreek Township Trustees. All debris is to be removed back to lot lines. Drainage is to be effective and workable.

In the event conditions are not restored promptly as required, the applicants certified deposit shall be forfeited at the discretion of the Trustees.

3. The applicant and/or contractor shall protect traffic at all times during the process of the work; will use proper barricades, signs, and/or lights so as to protect and provide safety for the general public.
4. The applicant and his/her contractor will at all times provide and maintain suitable driveways to and from abutting properties.
5. The applicant and his/her contractor also will backfill all excavations with materials suitable to and in a manner satisfactory to the Board of Sugarcreek Township Trustees.
6. The applicant and his/her contractor also agree to accept full responsibility for all claims for damages to persons or property which might arise as a result of this work, with the Sugarcreek Township Trustees being totally free of any responsibility in such claims.

No person shall make an excavation in any township road in violation of any resolution adopted pursuant to section 5571.16; except that, in the case of an emergency requiring immediate action to protect public health, safety, and welfare, an excavation may be made without first obtaining a permit, if such application is made at the earliest possible opportunity.

Revised code section 5517.99 states that anyone violating section 5517.16 shall be fined not more than two hundred dollars (\$200.00) or imprisoned thirty (30) days, or both.

NOTICE: Contractors and applicants must notify the Fire Department/911 of the road being closed in the district in which work is being done.
